# Staffing Shortages and ResiDex EHR Solutions

## Staffing Shortages are Severe Across the Country

The long-term care industry has long been aware that staffing challenges loomed. As baby boomers retire and age, the demand for housing and services has skyrocketed and the number of available workers to fill caregiving positions has shown a steady downward trend.



The phenomenon known as "The Great Resignation", in which we saw record numbers of people completely opt out of the workforce in 2020, exacerbated the long-term care industry's already growing fight to maintain adequate levels of staffing. Many of these workers have sought better wages and work environments, while others quit due to illness risks. Statistics earlier that year showed how long-term care facility residents and staff accounted for more than 201,000 COVID-19 deaths, and at least 23% of all COVID-19 deaths in the U.S. alone.<sup>1</sup>

Across a sample of 1,183 long-term care providers polled by the American Health Care Association and the National Center for Assisted Living (AHCA/NCAL), 99% of nursing homes and 96% of assisted living communities said they are facing some degree of staffing shortages.<sup>2</sup> Without enough staff, nurses and care providers across the country struggle with tasks like accurately recording and tracking medication administration, handling health records, obtaining medications from the pharmacy, and properly completing healthcare billing. A nurse in one of the severely understaffed centers in Chicago, when asked about how she manages with staffing shortages said, "The stress is unbearable. You've got to basically keep yourself safe, keep the residents safe, and then you've got to make sure that you do everything that you're supposed to do."

In addition, many care centers are operating at a financial loss. The industry that provides millions of Americans with life-sustaining care is in dire need of help. There is no one single solution to filling all staff positions and meeting financial needs, but electronic health records are part of the solution. #### Charting Efficiencies with RTasks by ResiDex

### **Enhanced Pharmacy Collaboration**

The Pharmacy Connect feature offers a one-way integration with your pharmacy allowing an effective process of medication reconciliation between facility and pharmacy. The nurse retains the ability to review and process meds, taking into account resident preferences and the degree of instruction needed in delegating med administration to staff.

Pharmacists can be granted limited access to RTasks, including a Pharmacy dashboard that includes need-to-know information such as resident admissions, discharges and 'holds', med changes, administration details (declines or misses), med counts, and refill needs.

#### Administrative Efficiencies

Administrators can work most effectively when they have the information they need to make informed decisions.
